THE ORGANISER

AVAG - Association of Greek Valuers

The non-profit Association AVAG (Association of Greek Valuers) was founded in 2009 under decision no 5336/2009 of the One-Member Court of First Instance Articles published on 04/02/2009 in order to promote and make known the significance of the valuation profession.

Today, AVAG has more than 1200 members from all over Greece. The Association's goal is to function as a collective body representing professional valuers and experts undertaking valuations for public and private sector entities, and to provide services aiming to upgrade the quality of valuations in Greece and the status of the valuer's profession in the Greek economy and society.

AVAG's principal activities include the following:

- upgrading the quality of valuations in Greece by organising special training programs;
- promoting and advancing the profession of valuer by undertaking a range of activities, such as participation in conferences, scientific bodies, exhibitions, etc.;
- transmitting the experience gained by valuers and exchanging views on valuation-related issues;
- ongoing training for valuers;
- determining and advancing professional standards and best practices;
- translating EVS into the Greek language and developing National Valuations Standards in line with EVS;
- formulating and applying a code of conduct;
- establishing a professional certification body for valuers that is recognised by the corresponding bodies in Europe and worldwide; AVAG is an AMA granting REV status to its members that fulfill the relevant requirements of the scheme. To date, 336 members have been nominated REV after successful participation in both written and oral examinations;
- establishing national certification schemes in cooperation with a professional certification body for real estate valuers (to date, 133 of its members are certified valuers) and plant & machinery valuers (35 of its members are certified valuers). The schemes are accredited by the Greek National Accreditation Body;
- representing Greek valuer-members at TEGoVA;
- defending valuers' work-related rights;
- collaborating with similar national or international bodies on issues of mutual interest.

AVAG has been a Full Member of TEGoVA since 2010.

BRIEF HISTORY OF TESSALONIKI



The city was founded in 315 BC, in the early years of the Hellenistic period. Its founder was Cassander, the King of Makedonia, who joined 26 scattered settlements of this area into a single city to honor his wife, Thessaloniki, who was the sister of Alexander the Great.

A trading post and harbor, Thessaloniki added strength and vitality to Vergina, the first capital and kingdom of Makedon, to Pella, the epicenter of Makedonian splendor, and the city of Dion, the magnificent ceremonial center. This land instilled the valour of Alexander the Great who led the epic campaign of the Asian conquest all the way to India.

During the Byzantine era (from 324 A.C to 1430) Thessaloniki grew even more. No wonder it was chosen as the co-reigning city of the Byzantine Empire alongside Constantinople – to prove just that there are several Paleochristian monuments, constituting a Unesco World Heritage Site

The city came under Roman rule and became the second largest city of the eastern Roman Empire and the second most important city of the Ottoman Empire until its liberation from the Turks and its incorporation into the Greek State in 1912. It is the main port of the Balkans and a commercial crossroad between the Mediterranean and Southeast Europe, as well as between Europe and Asia.

Thanks to its history and also its geographical position, Thessaloniki has become a long-standing multicultural city with many communities creating and living together in harmony.

Over the last 20 years, with the collapse of Eastern Europe's borders and the incorporation of Bulgaria and Romania to the European Union, these characteristics have become more striking. Historically one of Europe's oldest and most multiethnic cities, Thessaloniki is home to architectural marvels that testify to its centrality in Byzantine, Ottoman and Sephardic Jewish history.









Though it has only about one million people, compared with Athens's five million, Thessaloniki is widely considered the cultural capital of Greece. Festivals abound, most notably the International Film Festival and the Dimitria Festival which draw hoards of buffs to the city each October and November. Thessaloniki boasts an under-30s creative movement seen nowhere else in the recession-stricken home of ancient tragedy and democracy.

Thessaloniki is truly unique in the sense that it intricately marries its thousands-year-old multicultural heritage with cutting-edge art performances and cinematic avant-garde.

Thessaloniki is the second largest city of Greece with a metropolitan area that is estimated to have a population of over 1.1 million. Its history as a city spans over 23 centuries. Fertile field for the meeting of different cultures, it is also the main port of the Balkan area and a crossroad between the Mediterranean Sea and Southeastern Europe. The city has the privilege of a great historical past which is reflected onto the bustling, energetic and creative everyday life of a big young population generated through universities and other educational institutions.

The city has large museums (Archaeological, Museum of Byzantine Culture, State Museum of Contemporary Art, Jewish) and numerous art galleries.



Since its foundation by king Cassander of Makedonia in 315 B.C. and named after his wife and stepsister of Alexander the Great, Thessaloniki has always been a metropolis. The long history of the city is evidenced by the varied architectural forms from the Hellenistic era up to the end of the 20th century as well as by an astonishing Byzantine artistic heritage. 17 monuments in the city have been included in the UNESCO World Cultural Heritage list. Thessaloniki, the second largest city of Greece, is the principal gateway from the Mediterranean to the Balkans and Central Europe.

You will have the opportunity to see the White Tower, which is the symbol of the city, the International Trade Fair grounds, the University campus, the Galerious Arch, the Rotunda, St. Demetrius church the City Walls and the Upper city from where you will have a marvellous view of the city, of the Thermaic Gulf, of Mount Olympus and visit the Archeological Museum that houses a stunning exhibition of golden jewels.

Vergina, identified with ancient Aigai, listed as a World Heritage site, was the first capital of ancient Makedonia, where Phillip II, father of Alexander the Great was assassinated and Alexander proclaimed king. The today small village became world known due to the discovery of the Royal Tombs and especially that of Philip II, as there was supposed to be the burial place of the Makedonian Kings.

The underground museum exhibiting Phillip's grave and its contents, truly fit for a king, is one of the most remarkable archaeological displays in Europe.










